« Digital Stars Europe Ex-UK » becomes « Digital Stars Continental Europe »

Chahine Capital, a pioneer in quantitative Equity "Momentum" since 1998, has renamed its Digital Stars Europe Ex-UK fund to Digital Stars Continental Europe.

Launched in 2006, Digital Stars Continental Europe is an All Caps European equity fund, which aims at outperforming Europe ex-UK markets by identifying, through proprietary quantitative models, "star" companies, those with the ability to repeatedly surprise investors positively.

Digital Stars Continental Europe has delivered an annualized net of fee performance of +8.05% (Acc share class) since its inception in 2006, compared to +4.01% for the MSCI Europe ex-UK NR over the same period*. It has been awarded best fund over 10 years in Europe and 5 other geographical areas (France, Austria, Germany, Switzerland and the United Kingdom) in the Europe ex-UK Equity category of the Refinitiv Lipper Fund Awards** 2022.

Effective since September 27, 2022, this name change aims to provide investors with greater readability and will have no impact on its investment policy, risk/return profile, ISIN codes or any other features of the Sub-Fund's share classes.
