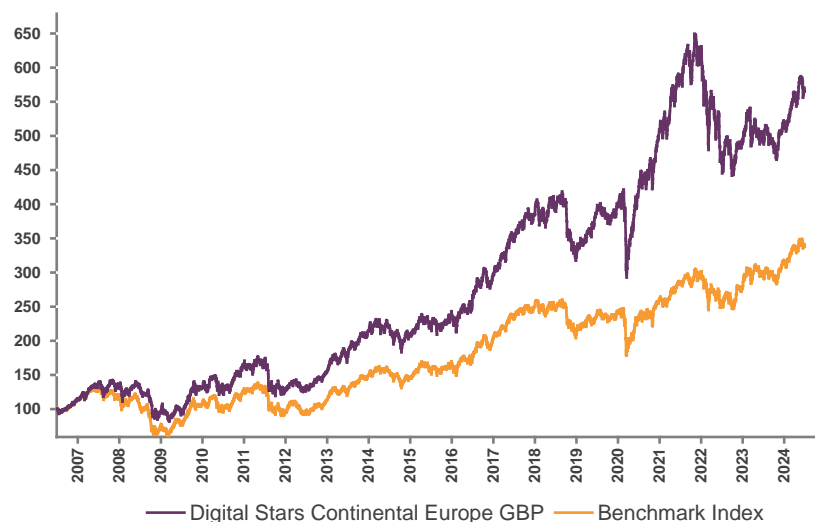

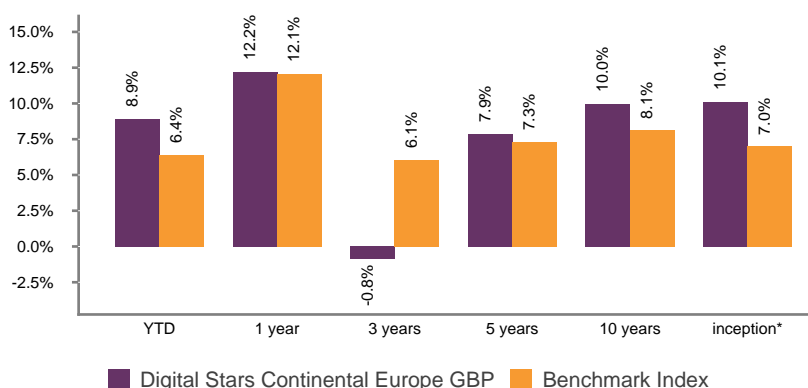

## PROFILE AND OBJECTIVE

A diversified, actively managed portfolio, invested in all market capitalisations based on a quantitative approach. The investment universe is comprised of about 1,300 European Union stocks (excluding the United Kingdom), Switzerland and Norway. The objective is to generate long-term capital gains and outperform European markets (excluding the United Kingdom) as a whole using a quantitative model to identify "Star" companies. There is no guarantee that the investment objective will be achieved or that there will be a positive return on investment.

## KEY RISKS

The fund invests in stocks of all capitalisations, belonging to different sectors and can undergo significant fluctuations in value. 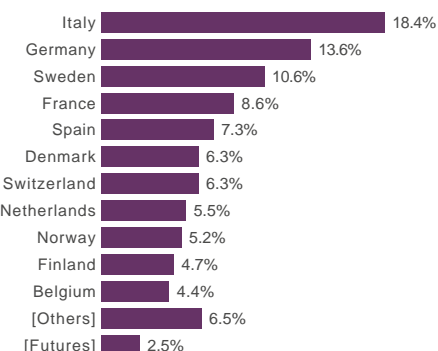

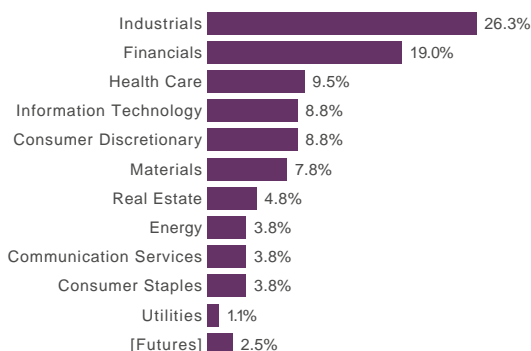
ASSET ALLOCATION AS OF 30/06/2024

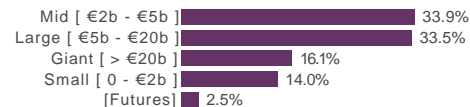

## GLOSSARY

<sup>1</sup> Beta is a relative risk indicator that measures the sensitivity of one financial asset to another asset, usually a market index.

<sup>3</sup> The Sharpe ratio is a risk-adjusted performance indicator.

<sup>4</sup> Tracking error is the measure of the relative risk taken by a fund in relation to its benchmark index. It is calculated as the annualised standard deviation of a fund's performance compared to its benchmark index.

<sup>5</sup> Outperformance fee: a fee that may be received by the management company in the event of performance greater than that of the Fund's benchmark index. Refer to the Fund prospectus for detailed information and examples regarding the method for calculating this fee.
