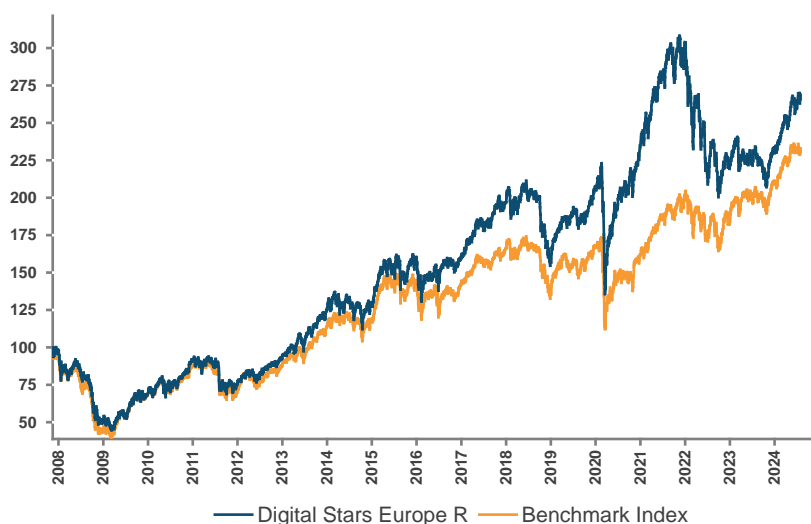

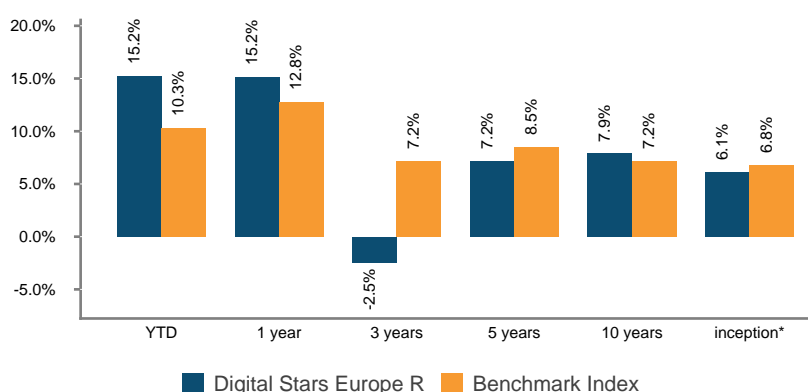

### PROFILE AND OBJECTIVE

A diversified, actively managed portfolio, invested in all market capitalisations based on a quantitative approach. The investment universe is comprised of about 1,700 stocks from the European Union, the United Kingdom, Switzerland and Norway.

The objective is to generate long-term capital gains and outperform European markets as a whole using a quantitative model to identify "Star" companies.

## GLOSSARY

<sup>1</sup> Beta is a relative risk indicator that measures the sensitivity of one financial asset to another asset, usually a market index.

<sup>2</sup> Volatility measures the magnitude of changes in the price of a financial asset. More specifically, this is the annualised standard deviation of the profitability of the asset in question.

<sup>3</sup> The Sharpe ratio is a risk-adjusted performance indicator.

<sup>4</sup> Tracking error is the measure of the relative risk taken by a fund in relation to its benchmark index. It is calculated as the annualised standard deviation of a fund's performance compared to its benchmark index.

<sup>5</sup> Outperformance fee: a fee that may be received by the management company in the event of performance greater than that of the Fund's benchmark index. Refer to the Fund prospectus for detailed information and examples regarding the method for calculating this fee.
