






PROFILE AND OBJECTIVE

The objective is to generate long-term capital gains and outperform eurozone markets using a quantitative model to identify "Star" companies. The fund seeks to limit the environmental, social and governance impacts of its investments and to promote securities least exposed to ESG risks. The fund invests in stocks of all capitalisations, belonging to different sectors and can undergo significant fluctuations in value. 


ASSET ALLOCATION AS OF 30/06/2024
